3.3.1 Error Identification

If an input error is automatically detected, the item that is in error is identified and the error is described to the user in text.

Partially Supports

The product uses message dialog boxes with text and different icons in it to show a type of the error.

Some dialogs may contain information about error without providing specific suggestion for correction.

3.3.2 Labels or Instructions

Labels or instructions are provided when content requires user input.

Partially Supports

The product provides additional information/tooltip to explain options/commands

Some buttons do not have tooltips to additional explain it.

1.3.5 Identify Input Purpose (2.1 only)

Partially Supports The product does not provide the ability to determine the expected meaning of input field programmatically in all cases.

1.4.3 Contrast (Minimum)

The visual presentation of text and images of text has a contrast ratio of at least 4.5:1, except in some limited situations (see link).

Supports

The visual presentation (background) of text for all options/elements in product provides sufficient contrast.

1.4.4 Resize text

Except for captions and images of text, text can be resized without assistive technology up to 200 percent without loss of content or functionality.

Partially Supports The text / labels in the product can inherit text resize from the environment system settings, but the text / labels can have difficulty in displaying

1.4.5 Images of Text

If the technologies being used can achieve the visual presentation, text is used to convey information rather than images of text except when the image of text can be visually customized to the user's requirements or a particular presentation of text is essential to the information being conveyed.

Partially Supports In most cases, the product uses text instead of images of text. Exceptions are for instance, marketing banners in product installer.

Where receiving and then removing pointer hover or keyboard focus triggers additional content to become visible/hidden, a mechanism is available to dismiss the additional content without moving pointer hover or keyboard focus; if pointer hover can trigger the additional content, then the pointer can be moved over the additional content without the additional content disappearing; and the additional content remains visible until the hover or focus trigger is removed, the user dismisses it, or its information is no longer valid (see link).

Headings and labels are clear and descriptive, so specific components can be easily identified within the content.

2.4.7 Focus Visible

Any keyboard operable user interface has a mode of operation where the keyboard focus indicator is visible.

Partially Supports The product uses visual changes to elements to indicate the current position of focus. In some cases a indication of the current position my not be visible.

3.1.2 Language of Parts

The human language of each passage or phrase in the content can be programmatically determined except for proper names, technical terms, words of indeterminate language, and words or phrases that have become part of the vernacular of the immediately surrounding text.

Does Not Support There is no mechanism to specify different languages for subsets of a form. Content is only presented in one language - English.

4.1.3 Status Messages (2.1 only)
